Founded in 2015, through joint £200 million investment between Government and Industry, CAM Testbed UK is a grouping of independent organisations with a common aim of promoting the UK as a global testing centre for the development, validation and deployment of connected and automated mobility (CAM) solutions.

A collection of physical and virtual capabilities, representing a cross section of real-world environments, CAM Testbed UK offers a comprehensive and coordinated testing facilities are world-leading, with a unique ability to cross-share data and a collaborative way of working.

CAM Testbed UK builds upon on the UK's advanced, comprehensive and coordinated CAM ecosystem, its world-class academic research community, and the UK's impressive talent pool.

The group is supported by the Centre for Connected and Autonomous Vehicles (CCAV), an expert, joint policy unit of the Department for Business and Trade and the Department for Transport. CCAV provides funding for CAM Testbed UK secretariat, through Zenic.

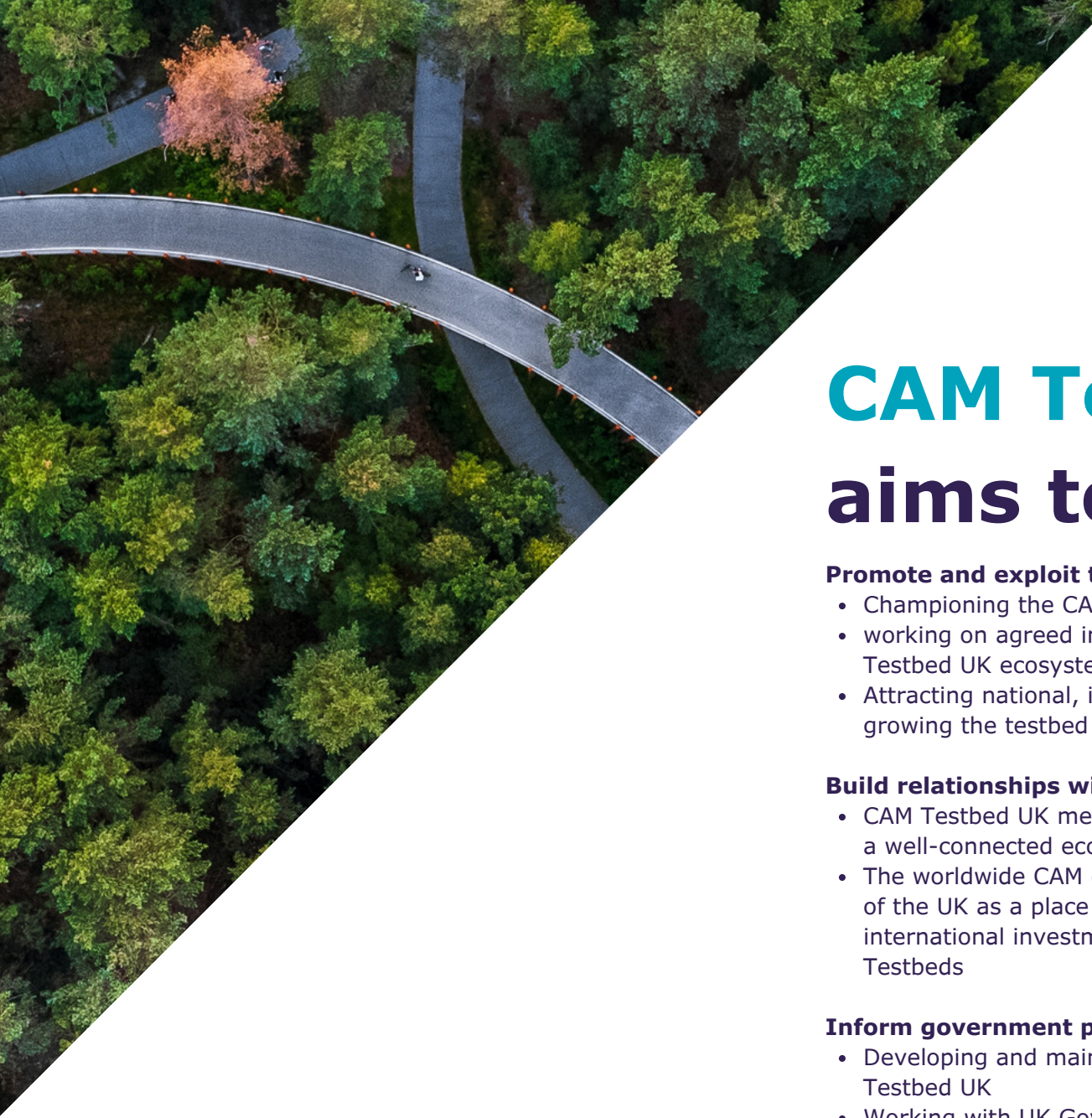

CAM Testbed UK Governance

We are governed by a member's steering board, including members from Testbeds, Zenzic and APC, as well as CCAV and provided with secretariat support by Zenzic.

CAM Testbed UK has an independent chair who supports the secretariat and Steering Group. The independent chair is voted for by members on an annual basis.

Working groups are established to deliver specific tasks, as directed by the Steering Group and all members will have the opportunity to join working groups and put forward for nomination for seat on the CAM Testbed UK Steering Board as and when vacancies arise.

For 2023/24 the Working Groups will be:

- Horizon Scanning
- Technical
- Marketing
- CAM Ecosystem

Description of membership roles



All members must:

- Join and contribute to at least one Working Group
- Support promotion and communications around CAM Testbed UK activity
- Bring with them the authority, resources and commitment necessary to complete the role or piece of work
- Not address specific company issues or pursue direct commercial interests through their input
- Recognise that the group exists to come to a consensus view in best interests of the ecosystem

A Steering Group Member must:

- Attend 5 out of 6 Steering Group meetings per year
- Chair or vice-chair at least one Working Group
- Be experts in their field and able to provide industry insight.

Membership application process

Membership of CAM Testbed UK is currently free however members are expected to commit 10 working days a year to support CAM Testbed UK activities

Should Government funding for CAM Testbed UK secretariat support end, CAM Testbed UK members may be asked to provide funding. Additional funding may be required on an ad-hoc basis to support agreed initiatives, such as branding and attendance at exhibitions

Requirements for membership of CAM Testbed UK

All members must be organisations who provide testing services:

- Physically or virtually
- In the connected, automated or mobility sectors
- Only land-based mobility
- All members must have a UK-based CAM testing facility that adds to current CAM Testbed UK offerings

All members must be an organisation which can contract and provide services to customers:

- Offer UK-based services or facilities
- Commit “in-kind” resource to the work of CAM Testbed UK
- Commit to a minimum of 1 day per month/12 days per year.
- Be willing to commit resource to support at least one Working Group.
- Sign the CAM Testbed Terms of Reference and abide by its principles - absolute commitment on competition compliance
- Be willing to carry CAM Testbed UK branding and contribute suitable material for inclusion on the CAM Testbed UK website
- Not all members are guaranteed a seat on the Steering Group
